3.5.1. Session cookies

This type of cookies are valid until the end of the browsing, when closing the browser this type of cookies are deleted automatically.



3.5.2. Third party cookies

Using Google Analytics, a service for statistical purposes, the Controller collect information about how the visitors use the website. The data is used with the purpose to develop the website and improve user-experience. 5.3. In relation of the social media platforms

Our website has several social media platform (for example LinkedIn, YouTube); so when a User "Likes" our page on LinkedIn or "Follow" us on YouTube, we will know every profile data and publicly available personal data. The relevant information of data management of these sites can be found in each provider own data management information.

6. User's rights and options to enforce rights

The Users anytime can ask for information about the details of personal data management free of charge, and in cases specified by law they can ask for modification, delete or restricted use of data.

4.1. Right of access

The Users can get a feedback from us about the management of their personal data, and they can access to these personal data and the details of their management.

4.2. Right to rectification

For the User's request we modify without an unwarranted delay the inaccurate personal data, and the Users are entitled to request the completion of their incomplete personal data by supplementary declaration.

4.3. Right of cancellation

For the User's request we delete their personal data, if we do not need them, or they withdraw their consent, or they protest against managing their data, or it is unlawful to handle their data.

4.4. Right to be forgotten

About the User's request to delete - if required - we try to inform every Controller, who has or may have become aware of the User's disclosed data.

4.5. Right to restrict data management

For User's request we restrict the data management, if the accuracy of personal data is questionable, or the data management is unlawful, or the User protests against managing their data, or we do not need the personal data anymore.



4.6. Right to data portability

The Users may receive their own personal data in a structure, widely used, computer readable format, and forward it to another controller.

4.7. Remedies

The protection of personal data is important for us, and at the same time we respect the User's right of self-determination, so we try to respond to every request correctly and in time. In the view of this, we ask the Dear Users to contact us if you wish to make a complaint before making official and court claims - to settle any dispute peacefully.

If the request does not lead to result, the User

- can assert their right in court based on Act V of 2013 of Civil Code (the lawsuit can be initiated before the competent court according to the place of residence or stay, you can view the contact information of the court of law on the link below: http://birosag.hu/torvenyszekek), and
